Personal information – collection and use

Collection and use of technical information

The web page of What Works Summits uses temporary "session" cookies which enable a visitor's web browser to remember which pages on this website have already been visited. Technical details in connection with visits to this website are logged by our internet service provider for our statistical purposes. - The type of web browser and operating system used by the website visitor.

It is the policy of Cognitio never to disclose such technical information in respect of individual website visitors to any third party (apart from our internet service provider, which records such data on our behalf and which is bound by confidentiality provisions in this regard), unless obliged to disclose such information by law. The technical information will be used only by Cognitio, and only for statistical and other administrative purposes
